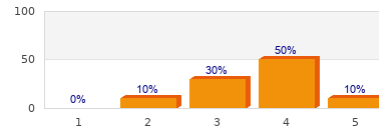

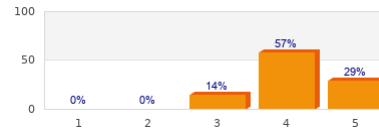

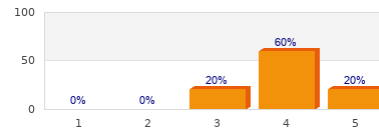

Very Dissatisfied



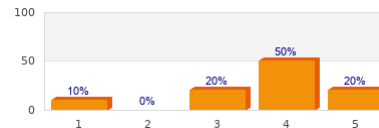

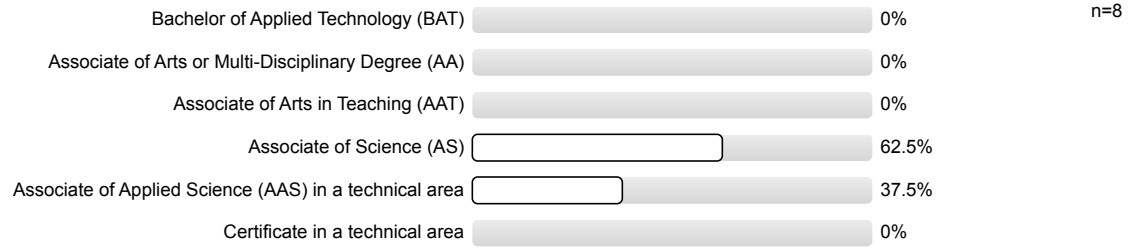

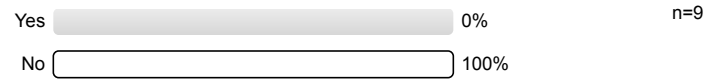
