### ADDENDUM A

#### PERFORMANCE OBJECTIVES

- 1. The student will not be allowed references. Content goals 1, 10 and 2 should be used as a study source. The student will complete an instructor administered test. Performance will be satisfactory if the student lists 60% of the content in correct chronological order.
- The student will be allowed references. Content goal 9 should be used as a study guide. The student will organize a sample personal record keeping system.
  Performance will be satisfactory if the scores a minimum of 60% on the check sheet for the record keeping system.
- 3. Using job assignments the student will complete a minimum of 15 weekly work experience forms. Content goals 3 8 should be used as reference. Performance will be satisfactory if the student scores a minimum of 45 out of the 75 available points.
- 4. The student will be allowed references. Content goal 11 and 12 should serve as a study guide. The student will list possible financial options, contact three of the options, calculate interest charges and select the best source of funding. Performance will be satisfactory if the selection can be justified based on interest and actual costs.
- 5. The student will be allowed references. Content goals 13 and 14 should serve as a reference. The student will identify personal insurance requirements, select one to do comparative shopping and make a recommendation. Performance is satisfactory if the student completes the assignment with a minimum score of 60%.
