Syllabus

Course Description: Principles of Macroeconomics is a course designed to teach the basic concepts and tools used for economic analysis. One of the goals of this course is to inform students who may be considering pursuing a degree in economics, and to prepare them for future coursework. The other goal is to teach you how to think like an economist, and apply economic reasoning to everyday situations. Even relatively simple economic principles can be powerful tools, and understanding them is important even for non-economists.

Course Policy

Course Objective: Once a student has completed this course, a student will be able to:

- 1. Explain the role of scarcity, specialization, opportunity cost and cost/benefit analysis in economics. Identify the determinants of supply and demand; demonstrate the impact of shifts in both market supply and demand curves on equilibrium price and output.
- 2. Define and measure national income and rates of unemployment and inflation. Identify phases of the business cycle and the problems caused by cyclical fluctuations in the market economy.
- 3. Define economic growth and identify sources of economic growth. Construct the aggregate demand and aggregate supply model of the macro economy and use it to illustrate the macroeconomic problems and potential fiscal policy solutions.
- 4. Define money and the money supply; describe the process of money creation by the banking system and the role of the central bank. Illustrate monetary policy solutions to macroeconomic problems.
- 5. Explain the mechanics and institutions of international trade and their impact on the macro economy.

Evaluation of the Students Performance: Students can view performance in the course by selecting the RESULTS tab within MyEconLab website. Discussion – The discussion board can be found under the Communication Tools tab in the Pearson My Lab website. **Participation in the discussion board is mandatory and counts towards a student's Participation Grade labeled Other Average in the grade book.** Questions, comments, and answering other student's posts increase a student's discussion grade with the **possibility of extra credit**. Due dates for the discussion questions and responses are available in the Communications tab. **There are two due dates for each chapter discussion.** One due date is for discussion questions and the other is for a response to a question. **Homework** – Homework is available in the Assignments tab within the MyEconLab website. Students must select the homework and then click the question that you would like to view. Answer the question and select Check Answer. Students do not have to complete the entire homework assignment at one time, however each question should be complete prior to the homework due date. Homework submitted after the due date receives a 30 percent penalty.

Quizzes – The quizzes are available in the MyEconLab website. Students are given only one attempt at the quiz. Once the quiz is launched students must complete the quiz within the allocated time. There is no option to save the quiz and return later to complete the quiz. Students will receive a zero for quizzes that are not submitted by the due date.

Exams - The exams are completed within the MyEconLab website. The days the exams are available is on the schedule provided. Once the exam is launched students must complete the exam within the allocated time. There is no option to save the exam and return later to complete it. Students will receive a zero for exams that are not submitted by the due date.

Optional Comprehensive Final Exam – The OPTIONAL comprehensive final exam will replace a student's lowest exam grade. The optional final exam cannot hurt your grade. For instance, if a student has scores of 75, 80, 85, 90, and 95 on the 5 exams and then scores a 60 on the optional final exam then the final exam score of 60 will not replace one of the higher exam scores.
