## Course Description

Singing more difficult tonal music in various clefs, aural study including dictation of more complex rhythm, melody, chromatic harmony, and extended tertian structures.

## Course Objectives

In this course, students will increase their aural awareness of music by singing what they hear and see, writing what they hear and sing, and hearing what they see and sing. Upon successful completion of this course, students will:

1. Apply a method of sight singing to more difficult tonal melodies, oral demonstration of complex rhythms.
2. Classify more difficult elements of music, including extended-tertian chords, compound intervals, and non-diatonic scales
3. Transcribe more complex rhythms and diatonic and non-diatonic melodies.
4. Transcribe and analyze diatonic and chromatic harmonies.
5. Read and reproduce rhythms in various meters, including syncopation and irregular beat divisions.

## Required Materials

### Required Textbook:

Cole, Samuel and Leo R. Lewis. *Melodia: A Course in Sight-Singing Solfeggio, Complete (Books I-IV)*. Bryn Mawr, PA: Presser, 1904.

- 3-ring binder with supplies for note-taking (including music staff paper and regular lined notebook paper)
- Computer with internet access

### **Attendance**

Punctuality and attendance are qualities expected of every musician. Regular attendance is crucial to success in this class. Each student is allowed **two** absences (excused or unexcused) without penalty. Each additional absence will lower the final grade by five points. For example: your average is 88, and you miss class five times. Your average would be lowered from 88 (B) to 73 (C). Eight or more absences will result in a grade of F for the class. Absences due to official university functions (ie Band/Choir/SGA trips, etc) are excused absences if the instructor is notified in advance. Exceptions to this policy will be made at the discretion of the instructor when consulted by the student.

- Both excused and unexcused absences count as absences. Excused absences (those in writing or with official documentation) allow submission of make-up work within one week of returning to class. If you know you are going to be absent, please notify the instructor as soon as possible.
- Just because you are allowed two absences does not mean you should use them. Look at them as a professional: they are sick days or professional leave days, not vacation days!
- Students are NOT guaranteed credit for work made up after unexcused absences (such as failure of your car to start). However, make up work is encouraged as partial credit may be given.
- Three tardies (five or more minutes late) will equal one absence. If a student is tardy it is their responsibility to inform the instructor that they were present; failure to do so may result in an erroneous absence.
- If you are absent, it is your responsibility to inquire about make-up work and materials covered in class either by another student, instructor or D2L.

Attendance is required for all exams, and all assignments are expected on the due date. 20 percentage points are deducted from late written or recorded assignments that are turned in by the next class period following the due date. Work will not be accepted after one week past the due date except in extenuating circumstances. There will be no make-ups for exams and in-class assignments except in extenuating circumstances. Extenuating circumstances must be accompanied by documentation and are subject to the instructor's discretion.

### **Course Schedule (Subject to Change)**

Week 1: Melodia 41-44, 61-64, review of diatonic solfege and rhythm syllables in simple and compound meters

Week 2: Melodia 45-48, 65-68, altered solfege, secondary dominants, subdivision-equivalence changing meter rhythms

Week 3: Melodia 49-52, 69-72, modal mixture, secondary dominants, beat-unit equivalence changing meter rhythms

Week 4: Melodia 53-56, 73-76, secondary leading tone chords, dual meter signature rhythms

Week 5: Melodia 57-60, 77-80, predominant modal mixture chords, super-subdivisions at slow tempos

Week 6: Review Melodia 41-80, review for exam

Week 7: Review & **midterm exam (Wednesday, October 7, regular class time)**

Week 8: Melodia 81-84, 101-104, Neapolitan sixth chord, augmented sixth chords, dance rhythms

Week 9: Melodia 85-88, 105-108, N6 and +6 chords, complex syncopation and ties

Week 10: Melodia 89-92, 109-112, blues scale, asymmetric duple meter rhythms

Week 11: Melodia 93-96, 113-116, modulating melodies and harmonies, asymmetric triple meter rhythms

Week 12: Melodia 97-100, 117-120, modulating melodies and harmonies, polyrhythms

Week 13: Review Melodia 81-120, review for exam

Week 14: Review and **final exam (Wednesday, December 9, 1:00-3:00pm)**
