COURSE OBJECTIVES

Course specific competencies and learning outcomes flow from Program Outcomes. Program outcomes are the <u>Differentiated Essential Competencies (DECs</u>), defined and published by the Texas Board of Nursing. (DEC) are defined in four categories: 1) Member of the Profession, 2) Provider of Patient-Centered Care, 3) Patient Safety Advocate, and 4) Member of the Health Care Team. Integral to program and course outcomes are the QSEN Competencies. The QSEN competencies are integrated with DEC competencies throughout the nursing curriculum; progressing from simple to complex.

I. Member of a Profession

LEARNING STRATEGIES

Learning strategies used in the course may include patient care or observation in agency clinical, preconference and post conference presentation and/or discussion, unfolding case studies, demonstrations, simulation, web-based activities, quizzes, models, and computer software programs to enhance student learning.

EMAIL

Students are expected to use and check their Brazosport College email address at least twice daily. Your Brazosport College email is the official form of communication. Other email address formats are unacceptable and unreliable. Important information will be conveyed to students via email. COURSE REQUIREMENTS

Students are required to follow course requirements and/or program policies as listed in your course syllabus and student handbook. Infractions of these policies may result in disciplinary actions. Students may receive a verbal/written warning along with counseling by instructor. Failure to adhere to the course requirements and program policies may also lead to dismissal from course, and/or dismissal from program.

Preparation for Class, Assignments, and D2L

- 1. Students are expected to complete all assignments including UWorld and any other assigned virtual experience prior to class and be prepared to participate in classroom discussion.
- 2. All assignments are due on the date and time designated by faculty. Assignments are considered late if not submitted by the specified time and due date. Late assignments will reflect on the week's formative evaluation grade.

The American Psychiatric Association (APA) Publication Manual is the selected style manual for nursing programs.

- 3. Desire to Learn (D2L) is the course platform for course resources.
- 4. IF assignments are scheduled for submission via D2L, the course schedule will specifically indicate D2L submission.
- 5. UWorld assignments and Swift River assignments will be available on the UWorld academic site
- 6. The Desire to Learn time clock is the official clock used for due date and time stamp.
- 7. Students must have access to a home computer with reliable internet access.

Academic Honesty Policy

Brazosport College assumes that students eligible to perform on the college level are familiar with the ordinary rules governing proper conduct including academic honesty. The principle of academic honesty is that all work presented by you is yours alone. Academic dishonesty including, but not limited to, cheating, plagiarism, and collusion shall be treated appropriately. Academic dishonesty violates both the policies of this course and the Student Code of Conduct. In this class, any occurrence of academic dishonesty will be referred to the Dean of Student Services for prompt adjudication and may result in failure in this course and program dismissal. Sanctions may be imposed beyond your grade in this course by the Dean of Student Services.

Attendance

Clinical attendance is mandatory.

Students unable to attend due to illness or family crisis must notify the appropriate faculty member.

- 1. Students must arrive to assigned unit or facility at designated time. If student is late, student must arrive to assigned unit no later than 15 minutes from the designated start time. The student must contact instructor or designated supervisor immediately as soon as tardiness is anticipated and again upon arrival to unit. Failure to arrive within this 15-minute period will result in the student being sent home and considered a clinical absence.
- 2. Notification is required prior to absence of assigned experience. Notification after scheduled start times results in an unexcused absence. Students who fail to notify (no call no show) instructor of clinical absence are placed on academic probation immediately and may be dismissed from the program. A second occurrence of failure to notify of an absence is automatic dismissal from the program. Any student failing to follow procedure must meet in person with the program coordinator to explain failure to follow policy and procedure.
- 3. In the event of a (+) COVID-19 result in the Spring 2022 semester, clinical absence resulting in more than 4 clinical days (including observation rotations) may result in RNSG 2362 "Incomplete" and the student will need to complete the required clinical hours in the subsequent semester pending agency availability. Note: In Spring 2022 semester, students are accommodated with <u>one</u> extended absence secondary to a (+) COVID result.
- 4. Notification guidelines include:

a. Students are required to contact the clinical instructor at least one hour prior to scheduled clinical assignment.

b. Notification **is required by email**. Notification may **also** include faculty preference such as GroupMe or text. Check with your clinical faculty.

- c. Student must not relay messages to instructors through other students or other personnel.
- d. See clinical rotation schedule for absence notification in specific observation experiences.
- 5. If events preclude student from clinical attendance and student is aware day before, instructor may be notified. Please be courteous and do not call instructor during late/early hours.
- 6. During inclement weather or other emergency, the student must make decision regarding safe travel. If Brazosport College's President closes campus, nursing classes will not meet. The BC college home page is the source for campus closing information. If college is open and student does not attend class, the student is absent.
- 7. Absence during a clinical day may be reflected on the formative evaluation. Make-up days and/or assignments may be required for clinical absence. Absences during a scheduled medical/surgical floor day may result in loss of observation experience and reassignment to floor.

Student Withdrawals

- 1. Course withdrawal policies follow published college policies and program policies in the current Associate Degree Nursing Student Handbook.
- 2. Voluntary withdrawal requires written notification by the student. This notification must be submitted to the Program Coordinator and it must include the reasons for withdrawing.
- 3. Courses dropped on or before semester census date are not recorded on student transcripts. Course withdrawals received after census date and before withdrawal deadline each semester is recorded on student transcripts as a course grade of 'W'. The last date to withdraw from this course is March 31, 2022
- 4. Students who have registered and paid for courses are considered enrolled until the student officially withdraws by submitting a withdrawal form to the registrar and Program Coordinator. Ceasing to attend class does not terminate enrollment. The student is liable for returning and repaying financial aid, scholarships, or any funds provided to the student.
- 5. Because withdrawal from classes affects enrollment in other courses, insurance eligibility, financial aid, and veteran's benefits; prior to finalizing withdrawal, students are advised to consult with Financial Aid Office and/or Veteran's Coordinator.

EVALUATION METHODS

Content mastery is assessed through formative clinical evaluations and dosage proficiency. Formative evaluations include, but are not limited to written clinical assignments, pre- or post-conference discussions, normed assessments and UWorld assignments, Swift River assignments, and critical thinking activities, and application via patient assignments.

GRADING CRITERIA

Course Grade

The final grade for this course is derived from the following components:

Instructor-led and Observation-led clinical will constitute 100% of the final grade for this course calculated through the summative evaluation. Summative evaluation consists of scores from weekly formative evaluations throughout the course.

Course average grade scale

The Brazosport ADN Program uses the following grading scale for overall course grades A = 92-100 B = 84-91 C = 78-83 D = 70-77 F = 69 and below

To successfullycomplete the course and progress in the program, the student must achieve a final course grade of "C" or higher. Final course grades are NOT rounded up to the next whole number. Example: students who earn a 77.9 final course grade will receive a 'D' letter grade.

Dosage Proficiency Exam

All RNSG 2362 students are required to demonstrate 100% proficiency in dosage calculation. Students will have a maximum of 3 attempts to demonstrate dosage calculation proficiency. If 100% proficiency is not achieved after the 3rd attempt, the student will be dismissed from the course per ADN program guidelines. The dosage proficiency exam must be passed prior to start of clinical.

Exam Policy

- 1. Students **earn** grades. Grades are not deserved or given. Grades are not inflated or curved. Students with grade dependent scholarships are responsible for earning required grades. Faculty members will not inflate or adjust grades or provide special assignments for students with scholarship or other financial return based on grades. Requesting faculty members to adjust grades is considered unprofessional behavior.
- 2. If the exam is online (such as dosage competency exams), it will occur in a synchronous manner at the time and date on the course schedule. All students must take the exam at the designated time/date. NO EXCEPTIONS. No books, papers, purses, phones, hats, drinks, food, gum, and other identified items are permitted during testing. No items are permitted on desks during exams, except pens/pencils and a blank sheet of paper. Calculators may be allowed at faculty discretion and for all dosage competency exams.
- 3. Students should be in seat or ready at computer lab and prepared to begin exams <u>at least 10 minutes</u> <u>before start time</u>. All books, papers, computers, purses, phones, hats, drinks, food, gum, and other identified items are not permitted in the computer testing lab. No items are permitted on desks during exams, except pens/pencils and a blank sheet of paper. Calculators may be allowed at faculty discretion.
- 4. Talking is not permitted and will be treated as academic dishonesty. Students with questions or computer issues should raise their hand and wait for the faculty member proctor.
- 5. Once an exam begins, no student may enter the exam without permission from faculty. No extra time is allowed for late students. Faculty have the right to close the exam and deny admission to late students.
- 6. Students may **NOT** leave the room once exam begins.
- 7. Students completing exams should exit quietly and leave area and return to class at time specified by faculty. Classroom management is up to lead faculty. Faculty are not to be compared.
- 8. Do not email or call faculty for early grades.

Late Work Policy

- 1. Absence from the clinical experience does not excuse or relieve a student from course requirements and deadlines. Alternate clinical experiences may be assigned for absences and will be due upon completion and/or within the assigned deadline.
- 2. Late assignments without a pre-event specific discussion with the course faculty may earn a grade of zero.
- 3. Assignments not submitted as specified are late and reflected on the weekly formative evaluation.

4. Late assignments must still be submitted electronically for time and date stamp.

Unsafe Practices Policy

To provide for optimal patient safety and consistency in student learning, the Associate Degree Nursing faculty developed the following guidelines for student clinical experiences.

The guidelines have been developed in conjunction with hospital personnel and current agency policies. Should a situation arise where an agency's policy is more restrictive than these guidelines, agency policy is followed.

- 1. When in observation setting, students are only there in observation and assessment capacity. Students may not perform interventions (such as administer medications and/or perform interventions).
- 2. Students will report status of assigned patients to the designated licensed nurse prior to leaving the unit. In the acute care setting students also document patient status and name and title of person to whom report was given in student nurse's notes.
- **3.** The student must notify instructor to be "in attendance" for any initial sterile procedure. For subsequent same skill performance, the student must have specific instructor approval to be independent or be with a designated nurse.
- 4. Students may not serve as witnesses for any legal documents such as wills, operative permits, narcotic waste forms or "witness" medications requiring signatures of two licensed personnel such as insulin.
- 5. Students who work must have adequate sleep to safely care for assigned patients and be able to remain awake and alert during pre-conference, clinical, and post conference. Licensed Vocational Nurses in the Transition ADN Program will NOT be allowed to participate in any clinical site if their employment work consisted of the night shift prior to the academic clinical experience. Example: A Transition ADN student worked all night and then reported to the clinical academic site. The faculty will send the student home because of safety risk, and the student may receive a zero for that clinical academic day.
- 6. Brazosport ADN Program forbids use of or appearance of, influence of narcotics (opioids and derivatives), hallucinogens (LSD, marijuana, and others), and alcoholic beverages while attending clinical or class. See College Catalog under Student Conduct and Program Handbook
- 7. Students may initiate CPR which is relinquished to clinical facility staff as appropriate
- 8. Many clinical facilities have implemented zero tolerance for smoking. This may include, but not limited to, smelling of smoke when entering facility or smoking in car or on facility premises (garage, parking lot, etc.). Students and faculty must be aware of clinical facility's policy and adhere to guidelines.
- **9.** Per agency and program policy, students alone are not allowed to take a patient from unit to a personal form of transportation once discharged. An employee of the facility must also be present.
- **10.** Any behavior in clinical area which exposes a patient to physical or emotional harm may cause a student to be dismissed from nursing program
- 11. See Criteria for Unsafe Practice located at the end of this syllabus
- 12. Refer to the Code of Conduct in the Student Handbook for further standards

Medication Policy

- 1. Students are expected to follow ADN program medication administration procedures and failure to follow this procedure will result in a '0' for the that day's clinical performance and academic probation. Multiple occurrences will not be tolerated and may result in program dismissal.
- 2. Students are not allowed to administer medications without instructor supervision and/ or approval.

- 3. Students may not open medication packages or remove medications from a multi-dose bottle without the presence of the clinical instructor and/or designated nurse for verification. Students must verbalize medication understanding with instructor prior to medication administration.
- 4. Students may NOT administer:
 - IV anti-neoplastic agents
 - Intrathecal medications
 - Central line/Porta-cath meds into ports not previously accessed
- 5. Students must NOT administer blood components that are typed and or cross-matched, such as RBCs, whole blood, platelets, fresh frozen plasma, cryoprecipitate, and plasma products used for coagulation factor deficiencies. Students may assist ONLY in monitoring patient responses to such therapies and witness the process for administering blood and blood products.
- 6. The following list of medications is not all inclusive but lists some medications that may require two licensed nurses to check dosage, order prior to administration.
 - Insulin
 - Lanoxin
 - Anticoagulants
 - Any "one-time dose" or stat medication
 - Mixed medications (i.e. narcotic and anti-emetic in a syringe)
 - Controlled substances
- 7. In all cases, the nursing instructor reserves the right to impose additional restrictions based on the learning level of the individual student and/or specific patient situation.

Student Conduct Statement

Reasonable accommodation: "Change in the way things are customarily done that will enable an individual with a disability to enjoy equal opportunities." (ADA 1620.20)

Performance requirements are basic activities a student must be able to complete in a reasonably independent manner. A student who poses a direct threat to health or safety of others or themselves does **not** meet clinical and skills competencies required by ADN Program. HIPAA
